On March 4, 2025, Staff of the South Dakota Public Utilities Commission (Commission) filed a Complaint against Garretson Natural Gas Utilities (Garretson). The Complaint alleged Garretson failed to maintain required pipeline safety records.

On March 6, 2025, the Commission electronically transmitted notice of the filing to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. On March 25, 2025, Garretson filed its Answer to the Complaint. On August 13, 2025, Garretson and staff filed a Settlement Stipulation and Agreement as a negotiated resolution in the Docket. Staff and Garretson agreed to \$5,000 penalty, with \$2,500 suspended upon the condition that Garretson implement the agreed Plan of Action and maintain the specified records for the next two inspection periods. On August 29, 2025, Garretson filed the Plan of Action.

The Commission has jurisdiction over this matter pursuant SDCL Chapters 1-26 and 49-45, specifically, SDCL 49-34B-5 and SDCL 49-34B-12.

At its regularly scheduled meeting of September 9, 2025, the Commission considered this matter. Having thoroughly reviewed the filings in the docket and after making further inquiry of the parties, the Commission voted unanimously to approve the Stipulation and assess a \$5,000 civil penalty against Garretson, with \$2,500 suspended, pursuant to the terms of the Stipulation and Plan of Action. It is therefore

ORDERED, that the Stipulation is hereby adopted and shall be incorporated by reference into this Order the same as if it had been set forth in its entirety herein. It is further

ORDERED that the Commission hereby assesses a civil fine in the amount of \$5,000, with \$2,500 suspended, against Garretson Natural Gas Utilities. It is further

ORDERED, that Garretson shall pay the unsuspended portion of the civil fine, in the amount of \$2,500 within 30 days of receipt of this Order Adopting Stipulation and Assessing Penalty. It is further

ORDERED, that if Garretson adheres to the terms of the Stipulation and Plan of Action, the \$2,500 suspended portion of the civil fine shall be discharged after a compliant 2028 inspection.
