## **South Dakota Public Utilities Commission Minutes of Public Hearing to Adopt Rules**

The Public Utilities Commission convened at 1:30 p.m. on Tuesday, July 15, 2025, in Room 413 of the Capitol Building, Pierre, South Dakota, to consider the amendment of the proposed rules 20:10:01:02.01, 20:10:01:02.05, 20:10:01:32, 20:10:22:05, 20:10:22:40, 20:10:22:41, 20:10:32:03, 20:10:32:12, 20:10:32:21, 20:10:32:42, 20:10:32:43, 20:10:32:43.02, 20:10:32:43.05, 20:10:32:43.06, 20:10:32:43.07, 20:10:32:53, 20:10:32:54, 20:10:32:55, 20:10:33:21, 20:10:33:27, and 20:10:37:01.
