#### SECTION 2 - RULES AND REGULATIONS

#### 2.1 Undertaking of the Company

This tariff contains the regulations and rates applicable to intrastate interexchange telecommunications services provided by the Company for telecommunications between points within the State of South Dakota. Services are furnished subject to the availability of facilities and subject to the terms and conditions of this tariff in compliance with limitations set forth in the Commission's rules. The Company's services are provided on a statewide basis and are not intended to be limited geographically. Company offers service to all those who desire to purchase service from the Company consistent with all of the provisions of this tariff. Customers interested in the Company's services shall file a service application with the Company which fully identifies the Customer, the services requested and other information requested by the Company. The Company reserves the right to examine the credit record and check the references of all applicants and Customers. The Company may examine the credit profile/record of any applicant prior to accepting the service order. The service application shall not in itself obligate the Company to provide services or to continue to provide service if a later check of applicant's credit record is, in the opinion of the Company, contrary to the best interest of the Company. The Company may act as the Customer's agent for ordering access connection facilities provided by other carriers or entities when authorized by the Customer, to allow connection of a Customer's location to a service provided by the Company. The Customer shall be responsible for all charges due for such service arrangement.

- 2.1.1 The services provided by the Company are not part of a joint undertaking with any other entity providing telecommunications channels, facilities, or services, but may involve the resale of the Message Toll Services (MTS) and Wide Area Telecommunications Services (MTS) of underlying common carriers which may be subject to the jurisdiction of this Commission.
- 2.1.2 The rates and regulations contained in this tariff apply only to the services furnished by the Company and do not apply, unless otherwise specified, to the lines, facilities, or services provided by a local exchange telephone company or other common carriers for use in accessing the services of the Company.

- The total charge for each completed call may be a variable measured charge dependent on the duration, distance and time of day of the call. Quick Tel proposes to offer 1+ and 101XXXX outbound dialing, 800/888 to fee inbound dialing, directory assistance, data services, travel card service, and propose calling service. A proposed tariff was filed by Quick Tel. The Commission has classified long distance service as fully competitive.

On April 5, 2001, the Commission electronically transmitted notice of the filing and the intervention deadline of April 20, 2001, to interested individuals and entities. No petitions to intervene or comments were filed and at its June 19, 2001, meeting the Commission considered Quick Tel's request for a certificate of authority. Commission Staff recommended granting a certificate of authority, subject to the condition that Quick Tel not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. Commission Staff further recommended a waiver of ARSD 20:10:24:02(8).

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-31, specifically 49-31-3 and ARSD 20:10:24:02 and 20:10:24:03. The Commission finds that Quick Tel has met the legal requirements established for the granting of a certificate of authority. Quick Tel has, in accordance with SDCL 49:31:3 demonstrated sufficient technical, financial and managerial capabilities to offer telecommunications services in South Dakota. Further, the Commission lines that there is good cause to waive ARSD 20:10:24:02(8). The Commission approves Quick Tels application for a certificate of authority, subject to the condition that Quick Tell not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. As the Commission's final decision in this matter, it is therefore

ORDERED, that Quick Tel's application for a certificate of authority is hereby granted, subject to the condition that Quick Tel not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. It is

FURTHER ORDERED, that the Commission finds good cause to wave APSO 20:10:24:02(8). It is

FURTHER ORDERED, that Quick Tel shall file informational copies of tariff changes with the Commission as the changes occur.
