INDEMNITY BOND to the PEOPLE OF THE STATE OF SOUTH DAKOTA

SOUTH DAKOTA PUBLIC UTILITIES COMMISSION

We, <u>Public Communications Services, Inc.</u> the principal and applicant for a CERTIFICATE OF AUTHORITY, to provide facilities-based local exchange and interexchange telecommunications services within the State of South Dakota, and <u>Plate River Insurance Company</u>, as and admitted surety insurer, bind ourselves unto the Public Utilities Commission of the State of South Dakota and the consumers of South Dakota as Obligee, in the sum of \$25,000.

This bond shall take effect as of the date hereon and shall remain in force and effect until the surety is released from liabilti8y by the written order of the Public Utilities Commission, provided that the surety may cancel this Bond and be relieved of further liability hereunder by delivering thirty (30) days written notice to the Public Utilities Commission. Such cancellation shall not affect any liability incurred or accrued hereunder prior to the termination of the said thirty (30) day period. The aggregate liability for this bond shall not exceed the penal sum.


