INDEMNITY BOND

To the

Such cancellation shall not affect any liability incurred or accrued hereunder prior to the termination of said thirty (30) day period.



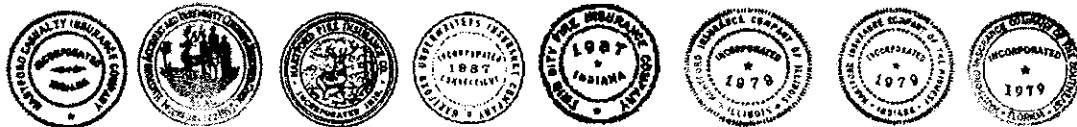
