

Dear Ms. Van Gerpen:

This letter is to inform the Commission that I, on behalf of Sprint Communications and MCC Telephony, Inc., have provided counsel for Swiftel the materials compelled at the Commission hearing yesterday. This includes an unredacted version of Appendix 5 and the information the Commission ordered to be produced out of Appendix 1.

MCC and Sprint both appreciate the Commission's willingness to grant them until tomorrow at noon to turn over the information. However, Sprint and MCC turned over the information approximately a day earlier given Ms. Sisak requested the Commission allow her to file prefiled testimony regarding these two items by next Tuesday, the day before the hearing.
