VENTURE COMMUNICATIONS COOPERATIVE'S
SUPPLEMENT TO PETITION FOR SUSPENSION

Venture Communications Cooperative ("Venture") hereby provides the following as a Supplement to the Petition filed in the above-referenced matter, as follows:

1. As stated in the Petition for Suspension or Modification of Local Dialing Parity and Reciprocal Compensation Obligations filed in this matter, Venture has conducted a study to determine the percentage of toll calls that are intraMTA. (Page 14 of the Petition) In that Petition, Venture indicated that, once the study was completed, Venture would supplement the Petition with an estimate of the increase in its reciprocal compensation expense if it must pay reciprocal compensation to Alltel and the other wireless carriers for such calls. The estimate is provided in the attached Confidential Exhibit A, Paragraphs II and III.
2. Venture also indicated that it would supplement the Petition with an estimate of the harm attributable to the symmetrical compensation requirement. (Page 15 of the Petition) The estimate is provided in the attached Confidential Exhibit A, Paragraph I.
