Thank you for your letter of June 12, 2006 in response to our **Bone Fide Request for Interconnection**.

Aventure has filed with the South Dakota Public Utilities Commission for certification as a Telecommunications Carrier in South Dakota. Aventure will, upon the South Dakota Public Utilities Commission granting our application, provide telecommunications for a fee directly to the public in the state of South Dakota.


I would remind you that, according to §51.301(c) (4) of Federal Communications Commission rules, "(c)onditioning negotiation on a carrier first obtaining state certifications" violate(s) the duty to negotiate in good faith.

We apologize for the typographical error in our original letter in which the word "Eastern" was inadvertently substituted for Vivian Telephone Company, d/b/a Golden West Telecommunications. We are sending a corrected version of that original letter with this letter. We will also file the corrected copy with the South Dakota Public Utilities Commission.

Under South Dakota Public Utilities Commission rules (§20:10:32:38.) "(i)f the rural company does not dispute that the request is a bona fide request, the commission shall initiate a proceeding to determine if the rural telephone company shall comply with the request unless the rural telephone company receiving the request waives its exemption."

Since Vivian Telephone Company, d/b/a Golden West Telecommunications has not filed to dispute the **Bone Fide Request** with the South Dakota Public Utilities Commission or Aventure Communication Technology, L.L.C., within ten (10) days as required by the Commission's administrative rules, is it Vivian Telephone Company, d/b/a Golden West Telecommunications intent to waive the rural exemption?
