Please provide an explanation of any service improvements not fulfilled in 2006 that were projected to take place in last year's certification filing. See Exhibit B and response to question 3 in last year's filing.

See attached file (YTD 2006 WALLC Ex. B). Please keep in mind that we are only partially through the 2006 year and additional changes may occur prior to the end of the year. EXHIBIT PROVIDED TO THE COMMISSION AS A CONFIDENTIAL DOCUMENT TO THE SUPPLEMENTAL FILING MADE ON 8/16/06 Were the cell sites for the Lyons and Baltic areas built? If no, explain why.

At the time of last years filing, WALLC was awaiting FCC concurrence in the Lyons and Baltic areas (among others). This concurrence was granted on November 14, 2005 and WALLC received its first USF support in January 2006. In WALLC's February 27, 2006 filing with the Commission, we reported our intent to construct a new site in the Lyons area in calendar year 2006. We are currently working on lease agreements for the Lyons site. Building permits and the site equipment has been received and we are estimating a 4th guarter of 2006 completion date.

Also, as we explained in RCC's February 27, 2006 filing with the Commission, the Sisseton (RCC) site replaces the Baltic ETC site commitment for WALLC. The proposal to construct a Lyons and Baltic site were made based on a request for joint certification. However, RCC and WALLC were granted separate designations by the Commission. Because of this, the amount of support received in the WALLC market did not support the construction of two sites, thus one of the WALLC site commitments was replaced by the Sisseton site in the RCC market as the support in the RCC market supported additional build out.

WALLC is currently projecting construction of a new site in the Baltic area in 2008.

 Please identify any 2006 service improvements that took place that were not on the 2006 projected list,

As reported in this year 2006 Service Improvement Plan, WALLC expects to:

- Construct a new site in the Lyons area
- Deploy Phase II E911 deployment.

These were not reported on our 2006 plan submitted in 2005.

5. Please provide the project start date and completion date of each improvement on Exhibit B in the present filing.

Included in response to item # 1.

Please explain why no new cell sites are projected for 2007.

The level of USF support received by WALLC is not substantial enough to provide for additional cell site builds in 2007. In fact, the operating expense for the Lyons site (to be constructed in 2006) exceeds the level of USF support WALLC expects to receive in 2007. WALLC's current plans for 2007 include the switch rehome which is described in #7.

Please explain "switch rehome" on Service Improvement Plan - Calendar Year 2007.

As explained in last years filing, WALLC currently leases a switching facility. WALLC plans to move from a leased switch facility to an RCC owned facility. This move should reduce our network operating expenses going forward while allowing greater flexibility
