§ 009.02A7 Demonstration of Ability of Northeast Nebraska Telephone Company (the "Company") to Remain Functional in Emergency Situations

- **Back-up power**

Each of the Company's central offices is equipped with battery power reserve and a back-up power generator.

- **Re-routing of traffic around damaged facilities**

The Company utilizes self-healing rings to provide protective routing for the majority of its wire centers. The Company is working toward including all of its wire centers on a ring configuration. Should damage occur to any of the Company's facilities not on a ring at this time, repair technicians would restore service to subscribers by the manual re-routing of circuits.

- **Traffic spikes**

The Company's switching equipment has overload protection consistent with industry standards and has been configured to manage traffic spikes resulting from emergency situations.
