Dear Ms. Van Gerpen,

Enclosed are the revised tariff pages of Sancom, consistent with the Settlement Stipulation (stipulation) in TC07-128, that will become effective on July 1, 2010. This stipulation was signed on July 21, 2008 by Sancom counsel, Jeff Larson, and Staff Attorney, Karen E. Cremer. The stipulation was then approved by Commission Order on October 3, 2008 and became effective as of July 1, 2008. We are filing these tariff pages to further reduce Sancom's access rates to the Qwest rates consistent with the Commission's prior order.

Per the stipulation, Sancom has reviewed the currently effective Qwest South Dakota intrastate access tariff and found that no South Dakota Qwest access rates have been updated since the signing of the stipulation. Therefore, the rates outlined in the stipulation are the access rates Sancom is implementing effective July 1, 2010, which is a decrease of \$0.01551 per access minute. Sancom is resending the effective tariff pages, which were originally sent and reviewed by SDPUC staff on July 1, 2008.

Therefore, per the stipulation, no further action is needed by the Commission at this time since these rates are consistent with the stipulation and were approved by the Commission. Please contact me if you have any questions. Thanks for your review.
