Peter Rasmusson, being first duly sworn on his oath, states and alleges as follows:

1. My name is Peter Rasmusson and I am the Vice President of Martin Group Inc. I have held that position at all times relevant herein.

2. Martin Group Inc. ("Martin") provided Carrier Access Billing Service (CABS) to Orbitcom during the period from November 2004 through June 2007.

3. As Vice President of Martin, I have personal knowledge of how Orbitcom's CABS bills were created during this time period.

4. For the period from November 2004 through June 2007, Orbitcom's CABS bills for Global Crossing's originating Direct Distance Dialed (ODDD) calls were not being calculated by applying the thirty-two percent (32%) Percent Interstate Usage ("PIU") to all ODDD calls. In the June 2007 timeframe, Orbitcom contacted Martin and directed Martin to apply the 32% PIU factor to all Global Crossing's ODDD calls and send revised bills to Global Crossing.


