

**REQUEST FOR FURTHER TEMPORARY SUSPENSION**

Come now the above named Petitioners, by and through their undersigned counsel, and hereby request the Commission for a further temporary suspension to implement LNP. This request is based on the following grounds:

1. On or about April 22, 2008, the parties in this docket entered into a Stipulation for Procedural Schedule. In said Stipulation, the parties agree that the Petitioner’s existing suspension be extended to August 8, 2008. The parties further agreed that “the LECs may seek a further temporary suspension as necessary, until November 8, 2008.”

2. The LECs are engaged in settlement negotiations with the Wireless Carriers, but the dockets have not yet been settled.

3. Discovery and pre-filed testimony is being exchanged among the parties, pursuant to the procedural schedule, as modified.

4. Hearing on the dockets is scheduled for September 4 and 5 and the decision date for the Commission is November 8, 2008.

5. Because the dockets have not been settled, and a decision date is set, Petitioners request a further temporary suspension, until November 8, 2008. If ordered to implement LNP by the Commission, Petitioners ask for an additional 90 days after the Order requiring implementation to implement LNP.

Wherefore, Petitioners respectfully move the Commission for a further temporary suspension, to November 8, 2008 or until 90 days after November 8, 2008, if ordered to implement LNP.


