RESPONSE TO INQUIRIES**

Knology Community Telephone, Inc. (the "Company"), by and through its attorney, responds to the South Dakota Public Utilities Commission Staff's inquiries received June 4, 2008, regarding the above reference docket.

1. Please explain why 2007 actual capital expenditures for all exchanges were less than estimated in last year's filing.

RESPONSE:

Knology's acquisition of PrairieWave closed in April, 2007. Once the transaction closed Knology re-evaluated total company estimated capital expenditures. Based on this re-evaluation it made adjustments to actual capital expenditures in order to continue to fulfill its ETC obligations in South Dakota.

2. Did any of the capital improvement targets not get fulfilled during 2007? If yes, identify which target and explain why the target was not met.

RESPONSE:

PrairieWave had a strong focus on providing superior telecommunications service to its customers. Since its acquisition of PrairieWave, Knology has continued this focus. It is Knology's opinion that based on the level of service provided by PrairieWave/Knology during 2007; the capital improvements that were made throughout the year enabled the company to meet its target.

3. Please explain why the 2008 and the 2009 estimated capital expenditures have been reduced from last year's filing.

RESPONSE:

As described in its response to number one above, Knology has re-evaluated all *historically forecasted capital expenditures*. Based on this re-evaluation, Knology feels the reduced 2008 and 2009 estimated capital expenditures are a more accurate representation at the present time. Knology continues to perform routine maintenance and should a need arise for additional capital expenditures, the forecast will be re-evaluated.
