
For its second amended application for waiver, in lieu of its application dated February 27, 2009, pursuant to ARSD 20:10:32:03(23), Midcontinent Communications ("Midcontinent") requests the following waiver associated with application:

1. By its application in this docket, Midcontinent seeks authority to provide local exchange service within the cities of Crooks and Baltic in the Crooks and Baltic exchanges of Alliance Communications. Midcontinent is able to satisfy the local service obligations provided in ARSD 20:10:32:10, as well as those provided by 47 U.S.C. § 214(e)(1). Midcontinent is not aware that the Commission has by rule established minimum service areas. However, to the extent that service of less than the entire Alliance study area requires a waiver, Midcontinent requests such a waiver of ARSD 20:10:32:15 under ARSD 20:10:32:18.

WHEREFORE Midcontinent prays that the Commission in its final order grant such waivers as may be necessary for Midcontinent to serve the area applied for.


