With more and more of our Venture Communications subscribers now able

to receive Venture Vision, we thought it was important to review the benefits of adding Video Assurance.

Keep in mind that the residential set top boxes and Gateways are and will remain the property of Venture. Once the equipment is installed on your premises, the customer will not alter, tamper with or remove the equipment and will exercise reasonable care to prevent damage or loss of the equipment. Upon termination of the video service, the equipment must be returned to Venture within 72 hours to avoid being billed for the equipment.



Lost or damaged remotes can be purchased from Venture. They can be replaced within 30 days of installation if there is a defect but if they show abuse, the customer will need to pay the replacement costs.

We suggest our customers add the video assurance option for \$1.50 per month. Video assurance covers the following:

- ~ remote replacement
- ~ reprogramming of remote to new TV's

~ TV and VCR wiring and recording issues that relate to the Venture Vision Video services.

Customers who do not subscribe to the monthly video assurance plan may be subject to a \$30.00 charge per service visit.

In addition, you may be eligible for the monthly savings if your household income is at or below 135% of the federal poverty guidelines. Qualifying income levels for the year 2008 range from \$14,040 for a single person household to \$48,060 for a family of eight.

Link-Up Program

Another Federal Program, Link-Up, provides for financial assistance with connection charges for new customers. This can provide a discount of 50% on your telephone connection charges.

If you meet the eligibility requirements, you can obtain an application from our main office in Highmore, the office in Sisseton or online at www.venturecomm.net. When you no longer participate in any of the qualifying public assistance programs, you are no longer eligible for Lifeline or Link-Up. You are obligated by law to notify Venture Communications when you are no longer eligible. Statement of Non-Discrimination

Venture Communications Coooperative, Inc. is the recipient of federal financial assistance from the Rural Utilities Services, an agency of the U.S. Civil Rights Act of 1964, as amended, Section 504 of the Rehabilitation Act of 1973, as amended, the Age Discrimination Act of 1975, as amended, and the rules and regulations of the U.S. Department of Agriculture, which provide that no person in the United States, on the basis of race, color, national origin, age, or handicap, shall be excluded from participation in, admission, or access to, denied the benefits of, or otherwise be subjected to, discrimination under any of Venture's programs or activities.

TV Broadcast Fee Added

Historically broadcast stations such as ABC, NBC, CBS and Fox have offered their signals for free to be rebroadcast on cable TV systems. The Federal Government required the networks to convert to a digital delivery system by February of 2009. Some of the broadcast stations have taken advantage of the opportunity to charge to retransmit their digital signal over the cable systems.

Unfortunately, the broadcast stations, and one in particular, has taken advantage of the situation. They have instituted a rate that we feel is, to a large degree, unreasonable. With the way the laws are written, Venture Communications has no leverage due to the fact that we are required to provide to our customers the Sioux Falls affiliates for all of the broadcast stations.

After negotiating with the various network stations, agreements have been finalized. We negotiated to reach the best scenarios to accomodate our customers, but, now we must recover the costs of the additional fees being charged to our video product. A \$1.03 TV Broadcast Fee will be added to each Venture Vision customer's bill this month and subsequent months.

number, provided by the South Dakota Department of Transportation and the South Dakota Highway Patrol, offers up-to-theminute information about weather and road conditions throughout the state.

By dialing **511**, land-based phone users as well as cellular customers can receive location-specific road and weather information on any Interstate, US or state highway in South Dakota, North Dakota and Minnesota.

Travelers should not confuse **511** with 911, the nationwide emergency response number. 911 should be called for any situation requiring police, fire department, ambulance or other emergency services. 911 is manned by trained public safety dispatchers throughout the state of South Dakota. 



Low Income Assistance Available to Telephone Subscribers

In response to concerns about the affordability of telephone service for low-income citizens, Venture Communications is authorized to offer Lifeline and Link-up to our customers. Lifeline and Link-up are federal telephone assistance programs. To be eligible for either of these programs, the applicant must participate in at least one of the following public assistance programs: food stamps, federal public housing assistance, low-income home energy assistance, Medicaid, or supplemental security income (SSI).

To be eligible for the Enhanced Lifeline or the Enhanced Link-up programs, the applicant must live on tribal land and participate in at least one of the following public assistance programs: food stamps, federal public housing assistance, Head Start (meeting income qualifying standards), low-income home energy assistance, Medicaid, national school lunch program's FREE lunch program, supplemental security income (SSI), tribally administered temporary assistance for needy families or Bureau of Indian Affairs (BIA) general assistance program.

Lifeline provides eligible subscribers with a credit of \$8.25 each month on the basic service portion of their telephone bill. The discount applies on the main home telephone line listed in the name of the eligible telephone company subscriber. Lifeline subscribers may also receive blocking of long distance calls on their telephone line at no charge. Link-Up provides eligible subscribers with reduced installation charges for their basic home telephone service. The reduction is 50% of the applicable charges or \$30, whichever is less. It does not cover the cost of wiring inside your home and is limited to one time per home address per subscriber. Enhanced Lifeline provides subscribers expanded eligibility opportunities and additional telephone service discounts. They may also receive long distance blocking on their telephone at no charge. Eligible subscribers for Enhanced Lifeline must live on Tribal Land. Enhanced Link-Up provides eligible subscribers with a reduction up to \$100 of charges for installation for basic home telephone service.

If you meet the eligibility requirements, you can obtain an application from our main office in Highmore or the office in Sisseton and return it to either location. You may also print off an application from our website at <u>www.venturecomm.net</u>. When you no longer participate in any of the qualifying public assistance programs, you are no longer eligible for Lifeline or Link-Up. You are obligated by law to notify Venture Communications and advise us of your ineligibility. Los legisladores federales y estatales consideran que toda persona en los Estados Unidos debería tener acceso a un servicio de telecomunicaciones de calidad, a un precio accesible. De hecho, han creado un sistema para lograrlo.

Si participa en programas, como cupones para alimentos, Medicaid, el programa nacional de almuerzos escolares gratuitos, el ingreso de seguridad suplementario o para vivienda en virtud de la Sección 8, o si su ingreso familiar está por debajo de un determinado umbral, es posible que reúna los requisitos para obtener un descuento en su factura telefónica.

Esta ayuda de "servicio universal" incluye:

- Asistencia Lifeline: proporciona descuentos mensuales en el servicio telefónico local
- Programa Link Up: reduce el costo de iniciar un nuevo servicio telefónico
- Servicio de tarifa limitada: le permite controlar los cargos de llamadas de larga distancia
- También hay descuentos adicionales disponibles para los consumidores elegibles que vivan en territorios tribales.

Federal and state lawmakers believe that every person in America should have access to quality, affordable telecommunications service. In fact, they've created a system to do just that.

If you participate in programs, such as food stamps, Medicaid, the national school free-lunch program, Section 8 housing or supplemental security income, or if your household income is below a certain threshold level, you may qualify for a discount on your telephone bill.

This "universal service" support includes:

- Lifeline assistance that provides discounts for basic monthly local telephone service
- Link Up that reduces the cost of initiating new telephone service
- Toll Limitation Service that allows you to control your long-distance charges
- Additional discounts for eligible consumers living on tribal lands
