Geos Communications, Inc (Geos) is discontinuing all of its VoIP and telephony operations. A relative small number of users have E-911 service from Geos. Thus, Geos hereby files its application for discontinuance of service and respectfully provides the following information:

1. **Name of carrier:** Geos Communications, Inc., a Delaware corporation.
2. **Address of carrier:** 430 N. Carroll Avenue, Suite 120, Southlake, Texas 76092.
3. **Service discontinuation date:** July 23, 2010.
4. **Geographic area where service is discontinued:** All geographic areas in the United States and worldwide.
5. **Service affected:** All telephony operations, including but not limited to, home ATA service and softphone.

On June 23, 2010 notice by email was given to all of Geos' customers. A copy of the email notice is attached hereto. Copies of this application are being provided to the state regulatory commissions, the state governors and the Secretary of Defense.

Geos is considered non-dominant with regard to the service being discontinued. Geos has revenue of approximately \$20K per month. As of June 23, 2010 Geos had 535 users who were connected and using an ATA or SIP device on its network. These would be users who are using this as a home or land line phone replacement.

This notice is intended to inform you that on July 23, 2010 your MyGlobalTalk services will no longer be available. Geos Communications has decided to discontinue all telephony services and mobile applications. Before the service is shut down, I would like to inform you of the following items.

- As of July 23, 2010 all international calling will be disabled.
- As of June 23, 2010 you will no longer be able to add additional pre-paid calling credit to your account.
- If you have a Unique Telephone Number (DID) associated with your account, you have 30 days to port the number to another provider.
- All services, including E911, will be completely disabled on July 23, 2010.
