Kara: On behalf of IntelePeer, Inc. ("IntelePeer"), the response to your inquiries are below. If you have any questions, please do not hesitate to contact me:

1) Please confirm: IntelePeer, Inc. does not intend to serve in non-Qwest areas, or those protected by the "rural safeguards."

Response: IntelePeer does not intend to serve non-Qwest service areas in South Dakota. Further, IntelePeer does not intend to serve those areas protected by the "rural safeguards."

2) If IntelePeer, Inc. latter desires to serve in non-Qwest, rural territories, confirm it will make the appropriate filings with the PUC.

Response: If IntelePeer desires to serve non-Qwest, rural service areas in South Dakota, IntelePeer will make the appropriate filing with the South Dakota PUC.

3) Does IntelePeer, Inc. object to a Certificate of Authority condition that: IntelePeer, Inc. be restricted to serve in Qwest territories.

Response: IntelePeer does not object to a Certificate of Authority containing a restriction that IntelePeer only serve Qwest territories in South Dakota.
