


4. In the briefing schedule established by the Commission, NAT (and any intervening parties supporting the Motion to Dismiss) should bear the burden of going forward with briefs in support of the Motion to Dismiss. Sprint requests that the scheduling order allow thirty (30) days following the receipt of any briefs in support of the motion, for Sprint and other parties opposing the Motion to Dismiss to file responsive briefs.
