Dear Mr. Templin:

Brookings Municipal Utilities d/b/a Swiftel Communications (Swiftel) has received the request of MCC Telephony of the Midwest, LLC (Mediacom), under Section 252(i) of the Communications Act of 1934, as amended, to adopt in its entirety the Interconnection Agreement between Swiftel and Sprint Communications Company L.P., that was approved by the South Dakota Public Utilities Commission (Commission) in Docket No. TC08-117 on November 25, 2008 (Underlying Agreement).

By their respective signatures below, Swiftel and Mediacom (the Parties) intend that this letter serves as their agreement for Mediacom to adopt the Underlying Agreement in its entirety under the following terms:

- 1. This Letter Agreement shall become effective upon approval by the South Dakota Public Utilities Commission (Commission). If for some reason the Commission rejects all or part of the Letter Agreement, either party may at its option declare the remainder of the Agreement void and be excused from any performance thereunder.
- 2. Mediacom was granted a certificate of authority by the Commission in Docket No. TC 06-188 by Order dated October 3, 2008, to provide local telecommunications service in certain designated areas of Brookings, South Dakota and this Agreement will cover services in the area designated in that Order only.
- 3. Mediacom adopts the Underlying Agreement in its entirety, including all recitals, terms and conditions therein.
- 4. In applying the Underlying Agreement, the Parties agree that MCC Telephony of the Midwest, LLC shall be substituted in place of "Sprint Communications Company L.P." throughout the Underlying Agreement wherever the latter appears.
- The Parties agree that notice to Mediacom as may be required under the Underlying Agreement shall be provided as follows:

5. If Mediacom does not file this Letter Agreement with the Commission for approval within sixty (60) days of the date of Swiftel's signature, Swiftel may rescind its agreement.
