APPLICATION FOR AMENDED CERTIFICATE OF AUTHORITY

Gold Line Telemanagement, Inc. ("Applicant" or "Gold Line" hereby applies to the South Dakota Public Utilities Commission ("Commission") for an order amending its original Certificate to Authority ("Application") to permit Applicant to remove Indemnity Bond requirements granted in Docket No. TC03-180 to offer prepaid calling card services in the sate of South Dakota. In support of its Application, Applicant provides the following information:


3. Applicant was granted a Certificate of Authority to offer prepaid calling card services in South Dakota on Docket TC03-180, the terms of which were contingent upon Applicant providing a \$25,000.00 indemnity bond naming the Commission and the South Dakota consumers as beneficiaries. In response "Gold Line" established Bond through the Lincoln Insurance Bond Company in the amount of \$25,000.00 on February 14, 2005. The bond was an on going note and expired upon the execution and bankruptcy of Lincoln Insurance Bond Company in 2010.

4. In November of 2010 "Gold Line", notified the commission a current Bond requirement was not met and requested correspondence on how to comply with the commission to date policies and procedures.
5. In March of 2011 the Commission's staff notified "Gold Line" if company submitted prior year 2010 balance sheet, financials, and income statement and documents provided evidence of strong improved financial standing the applicant may request a waiver to omit a specific item pursuant to SDCL 49031-4 rule 20:10:24:02.
6. "Gold Line" feels confident that a Bond insurer would renew a bond based on 2010, 2009, 2008 and 2007 financials. However, the cost of the bond is not an analytical sound business decision based on "Gold Line" miniscule revenue earned in South Dakota. "Gold Line" does not wish to withdraw from any potential prepaid markets in the stat of South Dakota.

WHEREFORE, "Gold Line" respectfully request the South Dakota Public Utilities Commission to issue an order amending its original Certificate of Authority to remove the rule "#(9) the most recent 12 month period, financial statements of the applicant including balance sheet, income statement, and cash flow statement. The applicant. The applicant shall provide audited financial statements, if available: of holding granted to provide prepaid calling card services in the state of South Dakota.




