## RESPONSES TO STAFF'S DATA REQUESTS

1-1) Please explain any benefits ITC's customers will see as a result of the establishment of the "Brookings Rural" rate center.

**RESPONSE**: It is highly unlikely that ITC's customers will notice any change with the establishment of a formal Brookings Rural Rate Center; however, the formal establishment of the Brookings Rural Rate Center will ensure proper routing of phone calls.

1-2) Will ITC's customers currently in the Brookings area be negatively affected in any way with the establishment of the "Brookings Rural" rate center?

**RESPONSE**: No. No change in services or pricing is planned or anticipated.

1-3) Please provide a map of ITC's service territory in the Brookings area, detailing which customers will be a part of the "Brookings Rural" rate center, as proposed.

**RESPONSE**: ITC is presently preparing a map and it will be submitted as soon hereafter as reasonably practicable.

1-4) Does the "Brookings Rural" rate center include customers both inside and outside the Brookings city limits?

### RESPONSE: Yes.

1-5) Are the calls an ITC customer in the Brookings area makes to a Swiftel Communications customer currently considered local calls? If so, will these still be considered local calls with the establishment of the "Brookings Rural" rate center? If not, what additional charges currently apply and/or will apply?

**RESPONSE**: ITC's customers in the Brookings area are currently able to subscribe to ITC's optional extended area calling plan to make calls to Swiftel Communications customers without

incurring long distance charges for each call. There is no anticipated change to ITC's optional extended area calling plan.
