14.1 General

Toll VoIP-PSTN traffic is defined as traffic exchanged between a Sprint Communications Company, L.P. end user and the customer in time division multiplexing ("TDM") format that originates and/or terminates in Internet protocol ("IP") format. This section governs the identification of Toll VoIP-PSTN traffic that is required to be compensated at interstate access rates (unless the parties have agreed otherwise) by the Federal Communications Commission in its Report and Order in WC Docket Nos. 10-90, etc., FCC Release No. 11-161 (Nov. 18, 2011) ("FCC Order").

All traffic between Sprint Communications Company, L.P. and the end user originates and terminates in VoIP format.

Toll Free 8YY Transit Traffic Service and Toll Free Database Access Service are applicable to Toll VoIP-PSTN traffic and will be rated at the charges set forth in the appropriate section of this tariff.

14.1.1 Rating of Toll VoIP-PSTN Traffic

Because all the Company's traffic is considered Relevant Toll VoIP-PSTN traffic it will be billed at rates equal to Sprint Communications Company, L.P. applicable tariffed interstate switched access rates as specified in Tariff F.C.C. No. 13.
