The Company was granted authority to provide facilities-based and resold local and interexchange services in Docket No. TC 1--081. If the Commission issues new certificates, the name should appear as "dishNET Wireline L.L.C."

This change is not the result of a corporate reorganization or a change of control. There will be no change in operations or to the Company's customers who will receive notice of the name change.
