Dear Ms. Van Gerpen:

This letter and the attachments are being filed to certify that Interstate Telecommunications Cooperative, Inc., Study Area Code 391679, formerly known as Stockholm-Strandburg Telephone Company, ("Company") has met the reporting requirements of 47 C.F.R. §54.304 and other FCC rules (including, but not limited to 47 C.F.R §51.917) and related requirements in the Federal Communications Commission's ("FCC"), November 18, 2011, USF-ICC Reform/Transformation Order ("USF-ICC").

The Company certifies in this filing that it is eligible to receive and has elected to receive CAF/ICC Recovery; however the Company is not seeking duplicative recovery. The Company also is providing confidential information that NECA filed on the Company's behalf to the proper agencies. The Company requests confidential treatment of the CAF ICC Support Page, Access Recovery Charge Output Report, and Interstate Test Period Lines Report, which have been labeled accordingly. The pages contain proprietary and confidential information of the Company and should be treated as such. The Company considers the information contained in Confidential NECA CAF Filing to be highly proprietary and confidential. Accordingly, pursuant
