Pursuant to SDC 49-31-20 and ARSD 20:10:34:02.02, Verizon Long Distance LLC ("VLD") respectfully notifies the Commission that, due to an internal restructuring, on or about November 15, 2014, Verizon Enterprise Solutions LLC ("VES") will merge into and transfer its customer base to VLD. VES and VLD are both certificated to provide intrastate resold interexchange telecommunications services in South Dakota, and VLD will continue to provide the same interexchange telecommunications services provided by VES, under the same rates, terms and conditions, following the merger. VES and VLD are affiliates, and both are single-member limited liability companies formed in Delaware and wholly owned subsidiaries of the same single-member, Verizon New York Inc., with the same officers and directors. VLD will remain a wholly-owned subsidiary of the same single-member, Verizon New York, Inc., following the merger.

VLD hereby certifies that that the parties have complied with the advance customer notice requirements outlined in ARSD 20:10:34:02.02(3), as required by ARSD 20:10:34:02.02(1). As evidenced by the attached copy of the customer notice, which was transmitted to all affected

Verizon Enterprise Solutions LLC to Merge with Verizon Long Distance LLC

If you currently subscribe to long distance and/or regional calling service provided by Verizon Enterprise Solutions LLC ("VES"), please note that Verizon plans to merge VES into Verizon Long Distance LLC ("VLD") to achieve efficiencies in serving our customers and operating our business.

Please note that if you select a carrier other than VLD, you may no longer qualify for bundle or promotional discounts, credits or prices that required your subscription to VES or VLD services and applied to local telephone or internet services provided by other Verizon companies.

If you have arranged an intrastate, interstate and/or international preferred carrier freeze on one or more of the services affected by the merger, the freeze will not preclude the transition of your service from VES to VLD. Any freezes you had will continue to apply to your account after the transfer.

Upon the closing of the proposed merger, VLD will provide services to you under the same rates, terms and conditions as VES offered prior to the closing and the same Service Agreement will continue to apply.
