**NOTICE BY THE SOUTH DAKOTA OF THE PROPOSED SALE OF LC**

On July 15, 2014, the South Dakota Public Utilities Commission received a joint application to approve the sale of certain local telephone exchanges (LTCs) from WideOpenWest Finance, LLC (WOW), a subsidiary of WideOpenWest Finance, LLC, and its subsidiaries Knology of the Plains, Inc.; Knology Telephone, Inc.; Knology of South Dakota, Inc.; and a referred to as "WOW! South Dakota") and Clarity South Dakota proposes to sell its local telephone exchanges and include number of local telephone exchanges and include Fourche, rural Beresford, Black Hawk, Box Elder, Colman, Davis, Deadwood, Elk Point, Flandreau, Lead, Lennox, Madison, Monroe, North Sioux City, Spearfish, St. Onge, Sturgis, Summerset, Tea, Verde, Whitewood, Worthing, and Yankton. The application for the following reasons: 1) while under the previous ownership, the networks were completed out of state, Clarity's focus will be on the networks located in South Dakota, Minnesota, and Wisconsin; 2) the network infrastructure; 3) there will be no change in the telephone exchanges resulting from the purchase and sale; 4) enhanced 911; 5) there will be no reduction in tax revenue resulting solely from the purchase and sale of the exchanges; 6) to providing modern state-of-the-art telecommunication services; and 7) discontinuance, reduction, or impairment of any service.

The public is invited to participate by providing written comments within 15 days of publication of this notice. Any member of the public may participate in the proceeding by following the procedures which is available at <http://egis.sd.gov/rules/Dis> may be obtained by contacting the Commission. If a party to the proceeding is demonstrated or if requested by a party, the Commission will issue a final decision under SDCL 49-31-59.
