Dear Ms. Van Gerpen:

Mobilitie Management, LLC ("Mobilitie Management," or "Applicant"), by its undersigned counsel, hereby responds to the Third Data Request of the South Dakota Public Utilities Commission staff, dated September 12, 2016 ("Third Data Request").

Mobilitie Management responds to the Third Data Request as follows:

3-1. **Pursuant to ARSD 20:10:32:03(2), provide the organizational structure of Mobilitie Management, LLC.**

Response: Please see attached CONFIDENTIAL **Exhibit A**.

3-2. **On the South Dakota Secretary of State's website, it appears that Mobilitie Management has other affiliates and subsidiaries not listed on the application, including Mobilitie Transport and Broadband, LLC and Mobilitie Engineering and Construction, LLC. In addition, Interstate Transport and Broadband appears to be an affiliate. Please explain Mobilitie Management's relationship to these companies and, pursuant to ARSD 20:10:32:03(7), provide the names and addresses of all of the applicant's affiliates and subsidiaries.**

Response: Mobilitie Transport and Broadband, LLC is an entity that was created during a planned corporate reorganization. While it was registered in a number of states, the entity is not operating and does not provide telecommunications service in any jurisdiction. Mobilitie Management, LLC is related to Mobilitie Engineering and Construction, LLC and Interstate Transport and Broadband through common ownership. Neither entity provides telecommunications service in South Dakota or any other jurisdiction. The relationship between Mobilitie Management, LLC and these entities is provided in confidential **Exhibit A**. Mobilitie Engineering and Construction and the other companies listed on the organizational chart that are not certificated telecommunications providers primarily provide financial, managerial, or technical services in support of Mobilitie, LLC and Mobilitie Management, LLC and their respective subsidiaries.

- 3-3. **Provide prior experience of the applicant's principals or employees in providing telecommunications services or related services in South Dakota or other jurisdictions, including the extent to which that experience relates to and is comparable to service plans outlined in the filed application.**

Response: All of Mobilitie Management, LLC's officers were also officers of Mobilitie, LLC and have extensive experience providing telecommunications service in South Dakota and other jurisdictions. Mobilitie, LLC is authorized to provide interexchange and local exchange telecommunications services in the State of South Dakota (*See Order Granting Certificate of Authority TC10-091, dated November 16, 2010*). Mobilitie, LLC and/or its subsidiaries is also authorized or registered with the relevant state authority to provide telecommunications in all 50 states, the District of Columbia, and the US Virgin Islands. Mobilitie Management, LLC is in the process of obtaining nation-wide authorization to provide service and is currently authorized to provide service in Alabama, California, Connecticut, Florida, Illinois, Iowa, Kentucky, Louisiana, Maine, Massachusetts, Missouri, Montana, Nebraska, New Jersey, New York, Nevada, North Dakota, Oregon, Rhode Island, South Carolina, Tennessee, Texas, Utah, Vermont, Washington, West Virginia, Wisconsin, Wyoming, the District of Columbia, and the US Virgin Islands.
