1.6. Response: Applicant does not plan on providing local exchange service in the service area of a rural telephone company. eNetworks does not plan to sign any interconnection agreements with any local exchange carrier as they do not plan to provide dial tone type services. The Company proposes to deploy underground and/or aerial fiber optic cable along with fiber and outdoor metro cell nodes. (A metro cell node is comprised of equipment and an antenna most typically mounted on or near a utility pole or light pole). Incumbent local exchange companies as well as other utilities with poles or conduit require the company to obtain CLEC licenses prior to any negotiations with the company.

1.7. The response for ARSD 20:10:32:03(10)(b) seems contradictory in reference to a toll-free number. Will it have a toll-free number in the future or not?

Response: Initially the company did not plan on having a toll free number based upon the direct nature of the relationship they have with their customers. However, the company has decided otherwise and now has 844-222-2344 as their customer service toll free number.
