


Figure 1: Network Drawing

  - (A) RLEC's network and local End Office
  - (B) CenturyLink, SDN, or *other carrier*, that currently transports 9-1-1 traffic to meet point / CenturyLink's Central Office location and specifically the 9-1-1 Selective Router
  - (C) CenturyLink 9-1-1 Central Office housing the Selective Router/s (S/R)
  - (D) Network Transport from the CenturyLink S/R to the PSAPS
  - (E) CenturyLink, SDN, or other carrier, that will transport 9-1-1 traffic to the NG9-1-1 Meet Point / POI
