In accordance with SDCL § 49-31-70 and ARSD 20:10:32:04, please be advised that on May 15, 2018, SQF, LLC (“SQF”) submitted an application for a Certificate of Authority to provide local exchange telecommunications services in the State of South Dakota (“Application”) with the South Dakota Public Utilities Commission (“Commission”).

Specifically, SQF seeks certification to provide local exchange telecommunications services in the territories of all Incumbent Local Exchange Carriers (“ILECs”) currently operating in the state. However, SQF is not seeking approval to provide services in areas of South Dakota designated as rural telephone service areas.

SQF intends to provide local telecommunications exchange services to business customers and government agencies located within the State of South Dakota. SQF does not intend to provide services to residential customers.

Pursuant to ARSD 20:10:32:04, each certified telecommunications company operating within SQF’s proposed service area may seek intervener status in any Commission proceeding held on the Application. Such requests for intervention need not meet the requirements of petitions to intervene set forth in ARSD 20:10:01 et seq.

SQF intends to provide service as soon as practicable upon approval of its Application.
