RE: In the Matter of the Annual Certification Related to Eligible Telecommunications Carriers (ETCs)

Use of the Federal Universal Service Support (P999/PR-18-8).

I have completed certifications to USAC and the FCC in this proceeding as approved by vote of the Commission at today's Agenda Meeting held in Rochester, Minnesota.

Certification was accomplished using the Universal Service Administrative Company (USAC) 54.314 Certification web site provided for states to certify ETCs for continuing high cost program participation and by timely USPS delivery of that certification to the FCC Office of the Secretary.

The Department of Commerce indicated in its statement before the Commission today that the related High Cost Program is expected to provide approximately \$200 million to companies expanding connectivity infrastructure in unserved or underserved areas of Minnesota.

This is the second time that Minnesota has electronically certified ETCs through this process. On-line records indicate the process to have been successfully completed. Certifications were submitted in a single filing. USAC confirmed the action. Staff compliments USAC in the performance of its on-line filing system in place for this year's process.
