To Whom It May Concern:

In accordance with SDCL Section 49-31-70 and ARSD 20:10:32:04, please be advised that on February 27, 2019, Communications Venture Corporation, d/b/a INdigital, submitted an Application for a Certificate of Authority with the South Dakota Public Utilities Commission to provide local exchange services in the State of South Dakota. On March 26, 2019, the Application was supplemented to also provide for interexchange services in the State of South Dakota.

INdigital seeks Certification so that it may provide enhanced 9-1-1 and next generation 9-1-1 services to state, local, and/or any governmental or quasi-governmental agencies involved in administering and delivering emergency services using the universal 9-1-1 dialing code throughout the State of South Dakota. INdigital does not intend to offer any retail telephone exchange services to either residential or business and user customers or to provide any wholesale exchange access services to any other carriers or service providers. However, in order to aggregate and transport emergency calls under calling data, INdigital may require an interconnection agreement which is similar to that made available to other competitive local exchange carriers.

INdigital is requesting these certifications in connection with its submission of a bid in response to request for Proposal No. 1569 issued by the State of South Dakota's Office of Procurement Management regarding emergency services IP network, statewide hosts remote call answering systems, and managed services. Assuming INdigital is successful in its bid, INdigital intends to provide service as soon as practicable upon approval of all necessary applications by the South Dakota Public Utilities Commission.
