
Dear Ms. Van Gerpen:

PETITION TO INTERVENE

COME NOW Boomerang Wireless, LLC (“Boomerang”) hereby petitions the Commission for intervention in the above captioned proceeding pursuant to SDCL 1-25-17.1 and ARSD §§ 20:10:01:15.02, 20:10:01:15.03 and 20:10:01:15.05. In support hereof, Boomerang states as follows:

1. Boomerang was designated in Docket No. TC13-035 by Order dated April 28, 2017, as an eligible telecommunications provider for both non-tribal and tribal service within certain non-rural areas of the State of South Dakota.

2. On April 24, 2019, North American Local, LLC (“North American”) filed a Petition with this Commission to be designated as an eligible telecommunications carrier (“ETC”) for lifeline services only, in 1) all non-rural telephone company wire centers within South Dakota, 2) all rural telephone company study areas within the state of South Dakota, and 3) all Tribal areas within the non-rural and rural telephone company areas within the state of South Dakota.

3. Pursuant to the provisions of SDCL 1-26-17.1 and A.R.S.D. 20:10:01:15.02, Boomerang is requesting “Intervener Status” in the above entitled proceeding because it is currently designated as an eligible telecommunications carrier in the service area in which North American is requesting designation.

4. Boomerang has a substantial interest in the outcome of this proceeding and may be directly affected by any order entered by the Commission in this docket.

5. Boomerang desires to intervene in order that it may fully review the application, receive documents, comment, present testimony, cross-examine witnesses and produce evidence either seeking to clarify or oppose North American's Petition, to the extent that such actions are required in the above entitled proceeding. Boomerang seeks to make certain that North American's Petition fully complies with all legal requirements and Commission orders.

6. Pursuant to 47 C.F. R. 54.101(a) and (b), SDCL 49-31-73 and A.R.S.D. 20:10:32:43 this Commission is vested with the authority to grant or deny North American's Petition.


WHEREFORE, Boomerang respectfully requests that the Commission grant as follows:


