STIPULATION

This Stipulation is made and entered into by and between Northern Valley Communications, LLC, AT&T Corp., Sprint Communications Company, L.P. and Staff for the Commission by and through their undersigned respective attorneys of record. The parties hereby and stipulate and agree as follows:


1. **Stay of Proceeding.** The parties stipulate that the Commission may stay this proceeding and leave the docket open pending a final determination by the Federal Communications Commission (the “FCC”) in the matter of *In re N. Valley Commc’ns, LLC Tariff F.C.C. No. 3*, WC Docket No. 20-11, Transmittal No. 12, Order (rel. Jan 10, 2020) (“Northern Valley Matter”). For purposes of this provision, a “final determination” by the FCC shall include resolution of any petition for reconsideration of a Bureau order.

2. **Proceedings Post FCC Determination.** Within 10 days of the FCC’s final determination in the Northern Valley Matter, the parties shall meet and confer and if the parties cannot agree on a resolution of this matter they shall inform the Commission that the parties request that this matter be scheduled for further proceedings before the Commission.

3. **Commission Order.** The parties request the Commission to enter an Order consistent with this Stipulation.


