APPLICATION

Simwood Inc. (“Simwood” or “Applicant”) by its undersigned counsel and pursuant to Sections 20:10:32:03 and 20:10:24:02 of the Administrative Rules of South Dakota, hereby applies for a certificate of authority from the South Dakota Public Utilities Commission (“Commission”) to provide local exchange services and interexchange long distance services in the state of South Dakota.

COMPETITIVE LOCAL EXCHANGE SERVICES

Applicant has been authorized to provide competitive local and interexchange service in the states of Kentucky, Missouri, Montana, North Dakota, Oregon, Texas, and Wisconsin. Applicant has pending applications to provide competitive local and interexchange service in the states of Arkansas, California, Colorado, Florida, Idaho, New York, West Virginia, and Wyoming.

(8) A list and specific description of the types of services the applicant seeks to offer and how the services will be provided including:

(a) Information indicating the classes of customers the applicant intends to serve:

Applicant intends to serve business and enterprise customers.

(b) Information indicating the extent to and time-frame by which applicant will provide service through the use of its own facilities, the purchase of unbundled network elements, or resale:

Applicant intends to provide service as soon as practicable upon grant of this Application through all methods described above: the use of its own facilities, the purchase of unbundled network elements, or resale. Initiation of certain operations will first require negotiation of interconnection agreements with other service providers. As the time periods required to complete such negotiations may vary, a firm timeline for the initiation of service has not yet been established.

(c) A description of all facilities that the applicant will utilize to furnish the proposed local exchange services, including any facilities of underlying carriers:

Applicant does not currently own facilities or property in South Dakota. Applicant owns switching facilities elsewhere in the country that can be used to service South Dakota customers. Applicant intends to collocate switching facilities in each LATA within South Dakota. To facilitate deployment of services, Applicant intends to enter into interconnection agreements and/or other agreements with other service providers as permitted under the federal Telecommunications Act of 1996, 47 U.S.C. § 251(c).

(d) Information identifying the types of services it seeks authority to provide by reference to the general nature of the service:

Applicant will provide local access telecommunications service (local exchange) as well as 1+ Service (long distance or interexchange service) to business/enterprise customers. Service will be provided by resold services or a combination of resold services, lease of unbundled network elements (UNEs) provided by other carriers through interconnection or commercial agreements, and use of Applicant's own switching facilities.

(9) A service area map or narrative description indicating with particularity the geographic area proposed to be served by the applicant:

Applicant proposes to offer services throughout the state of South Dakota in all exchanges to the extent open to competition.

(10) Information regarding the technical competence of the applicant to provide its proposed local exchange services including:

(a) A description of the education and experience of the applicant's management personnel who will oversee the proposed local exchange services:

Applicant is technically and managerially qualified to provide services in South Dakota. Thomas Hadden, COO, will oversee Applicant's operations in South Dakota. As seen in his

biography, Mr. Hadden has more than 25 years of experience in the telecommunications industry. A description of the professional background and experience of Simwood's key managerial and technical staff is attached as Exhibit D.

(b) Information regarding policies, personnel, or arrangements made by the applicant which demonstrates the applicant's ability to respond to customer complaints and inquiries promptly and to perform facility and equipment maintenance necessary to ensure compliance with any commission quality of service requirements:

Business and enterprise customers seeking services will sign individual-case-based contracts that will govern the customer support received. Customers may initiate trouble tickets through online customer service or by calling customer support at (833) 857-2360. Customer service operates during normal business hours, and customers may leave messages during non-business hours.

(11) Information explaining how the applicant will provide customers with access to emergency services such as 911 or enhanced 911, operator services, interexchange services, directory assistance, and telecommunications relay services:

Applicant will rely upon ILECs and other carriers for the provision and access to emergency services (911 or E911), operator services, directory assistance, and telecommunications relay services.

(12) For the most recent 12-month period, financial statements of the applicant consisting of balance sheets, income statements, and cash flow statements. The applicant shall provide audited financial statements, if available:

Applicant Simwood Inc. is a wholly owned subsidiary of Simwood Group PLC. While the parent company Simwood Group PLC has audited financial statements, the subsidiary (Simwood Inc.) does not have separate audited financial statements. See attached Confidential Exhibit E which contains Simwood Group PLC's audited financial statement including a balance sheet and

income statement for the 12-month period ending November 30, 2018. The audited financial statements for Simwood Group PLC's fiscal year ending November 3, 2019, are not yet available.

(13) Information detailing the following matters associated with interconnection to provide proposed local exchange services:

(a) The identity of all local exchange carriers with which the applicant plans to interconnect:

Applicant has not yet identified which local exchange carriers it will interconnect with in order to provide its services. Applicant will enter into interconnection agreements with other certificated LECs as Customer demand warrants.

(b) The likely timing of initiation of interconnection service and a statement as to when negotiations for interconnection started or when negotiations are likely to start:

Applicant intends to begin interconnection negotiations and initiate interconnection service as soon as possible, though firm timelines have not yet been established.

Applicant has not yet made requests for interconnection to any local exchange carriers.

Applicant utilizes a direct sales approach to its marketing efforts. Applicant does not utilize any form of multilevel marketing in the sale of its services. Applicant uses written or electronic Letters of Authorization to prevent the unauthorized switching of local service customers.

Applicant has not been the subject of any complaints filed with any state or federal commission regarding the unauthorized switching of a customer's telecommunications provider or the act of charging customers for services that have not been ordered.

Applicant will notify its business and enterprise customers of any materially adverse changes to the rates, terms, and conditions of Applicant's services pursuant to the terms of their individually negotiated contracts which will include provisions for 30 days' notice in advance of material adverse changes.

No waiver is requested.

Applicant's participation in the market for local exchange and interexchange telecommunications services in South Dakota will promote consumer choice by expanding the ability of innovative, high quality, reliable and competitively priced telecommunications services. The granting of this Application will have the effect of increasing competition and, as a result, may compel other local telecommunications providers to improve their existing services, increase the quality and efficiency of their operations, and introduce innovative new services of their own. Moreover, the addition of the Applicant to the South Dakota local telecommunications market makes it likely that consumers of telecommunications services in South Dakota will receive the

benefits of downward pressure on prices, improved customer responsiveness and access to increasingly advanced telecommunications technology. Applicant's participation in the market will expand service options for customers in South Dakota, and will increase and facilitate competition in South Dakota by expanding the diversity of suppliers within the telecommunications marketplace.

CONCLUSION

Accordingly, Applicant respectfully requests that the Commission grant this Application expeditiously and issue a certificate of authority for Applicant to provide local exchange and long-distance service throughout the State of South Dakota.




