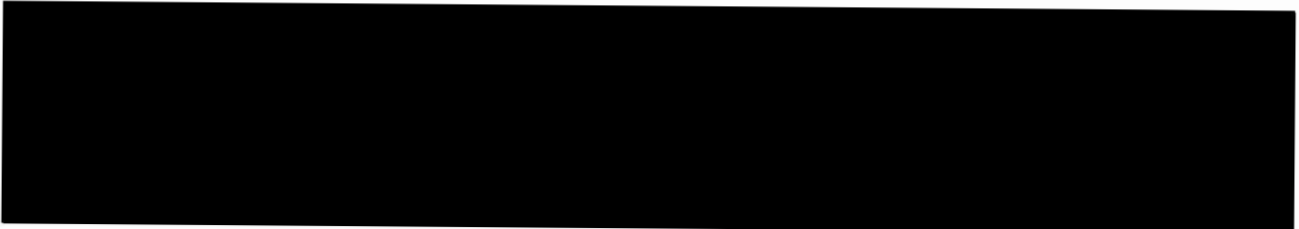
West River Telecommunications Cooperative ("WRT"), by and through its attorney, responds to Staff's Data Requests as follows:

Response: Attached is an updated letter with the 2020 federal poverty guidelines.

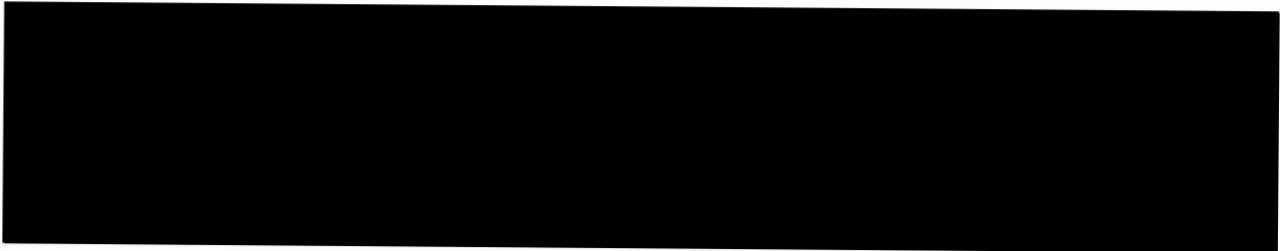
- 1-2. Refer to the "View Federal Poverty Guidelines: section of the Company's website. Update this section with the 2020 federal poverty guidelines.**


