Attached is the RDOF materials regarding LTD's plan as promised. These are being designated "Attorneys' Eyes Only" under the stipulation for protective order that we executed yesterday.

Also, I wanted to try to get the schedule done. Although we do not think SDTA really needs 4 weeks to complete prefiled testimony after completion of discovery, we are willing to agree to your proposed schedule if we agree to have a joint call with Staff the week of September 20 to discuss options for accelerating the schedule and avoiding an evidentiary hearing. So, with that in mind, we propose the following schedule:

- 1) Aug 27 for completion of discovery (meaning that all discovery requests would be served on or before that date).
