On April 13, 2021, the South Dakota Public Utilities Commission (Commission) received an application from LTD Broadband, LLC (LTD) for Certificates of Authority to Provide Resold and Facilities-based Local Exchange and Interexchange Telecommunications Services in the State of South Dakota. The Application specifies LTD does not intend to provide retail voice telecommunications services nor switched access services, but LTD intends to provide private line services and may seek interconnection agreements with incumbent local exchange carriers and wholesale telecommunications contracts to supplement LTD's services and may provide other arrangements such as dark fiber, fiber spectrum leases or other high-capacity services.

On April 15, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of April 30, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. On April 15, 2021, the South Dakota Telecommunications Association (SDTA) filed a Petition to Intervene. On July 29, 2021, SDTA and LTD filed a Joint Stipulation. On November 30, 2022, LTD filed a Motion to close the docket.

The Commission has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-31 and ARSD Chapters 20:10:01, specifically 20:10:01:02.04, 20:10:24 and 20:10:32.

At its regularly scheduled meeting of January 5, 2023, the Commission considered this matter. Finding good cause, the Commission voted unanimously to grant LTD's Motion to Close the docket. It is therefore

ORDERED, that LTD's Motion to Close the docket is hereby granted. It is further

ORDERED, that the docket is closed.
