On May 20, 2021, the South Dakota Public Utilities Commission (Commission) received a filing pursuant to 47 U.S.C. § 252 for approval of the FCC Modernizing Unbundling and Resale Requirements Amendment to the Interconnection Agreement between Qwest Corporation dba CenturyLink QC (CenturyLink) and Clear Rate Communications, Inc.

On May 27, 2021, the Commission electronically transmitted notice of the filing of the Amendment to the Interconnection Agreement to interested individuals and entities on the Commission's PUC Weekly Filings electronic listsery. The notice stated that initial comments were due June 9, 2021. No comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and the Federal Telecommunications Act of 1996.

At its June 10, 2021, meeting, the Commission considered whether to approve the Amendment to the Interconnection Agreement between CenturyLink and Clear Rate Communications, Inc. Commission staff recommended approval.

In accordance with 47 U.S.C § 252(e)(2)(A), the Commission found that the Amendment to the Interconnection Agreement does not discriminate against a telecommunications carrier that is not a party to the Amendment to the Interconnection Agreement and the Amendment to the Interconnection Agreement is consistent with the public interest, convenience, and necessity. The Commission unanimously voted to approve the Amendment to the Interconnection Agreement. It is therefore

ORDERED, that the Commission approves the FCC Modernizing Unbundling and Resale Requirements Amendment to the Interconnection Agreement between CenturyLink and Clear Rate Communications, Inc.
