On May 24, 2021, the South Dakota Public Utilities Commission (Commission) received a filing pursuant to 47 U.S.C. § 252 for approval of the FCC Modernizing Unbundling and Resale Requirements Amendment to the Interconnection Agreement (Amendment) between Qwest Corporation dba CenturyLink QC (CenturyLink) and EnTelegent Solutions, Inc.

On May 27, 2021, the Commission electronically transmitted notice of the filing of the filing to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The notice stated that initial comments were due June 14, 2021. No comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and the Federal Telecommunications Act of 1996.

At its regularly scheduled meeting of July 6, 2021, the Commission considered whether to approve the negotiated Amendment between CenturyLink and EnTelegent Solutions, Inc. Commission staff recommended approval.

In accordance with 47 U.S.C § 252(e)(2)(A), the Commission found that the Amendment does not discriminate against a telecommunications carrier that is not a party to the Amendment to the Interconnection Agreement and the Amendment is consistent with the public interest, convenience, and necessity. The Commission unanimously voted to approve the Amendment to the Interconnection Agreement. It is therefore

ORDERED, that the FCC Modernizing Unbundling and Resale Requirements Amendment to the Interconnection Agreement between CenturyLink and EnTelegent Solutions, Inc. is hereby approved.
