**ORDER APPROVING TARIFF
REVISIONS

On May 28, 2021, the Commission received a filing by Northern Valley Communications, LLC for approval of revisions to its Access Service Tariff No. 1. This filing proposes the first step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143. Northern Valley Communications, LLC requests an effective date of July 1, 2021. On June 28, 2021, Northern Valley Communications, LLC filed revised tariff pages.

On June 3, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of June 18, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. The requested effective date is July 1, 2021. On June 28, 2021 Northern Valley Communications, LLC filed revisions to its original submission.
