On June 7, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from Clarity Telecom, LLC dba Vast Broadband (Clarity) for approval of revisions to its Access Services Tariff No. 1. The purpose of this filing is to bring Clarity's tariff into compliance with the Federal Communications Commission's (FCC) October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143. Clarity requests an effective date of July 1, 2021.

On June 10, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of June 25, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On August 12, 2021, Clarity filed revised tariff pages.
