On June 10, 2021, the South Dakota Public Utilities Commission (Commission) received a filing by MCImetro Access Transmission Services Corp. dba Verizon Access (Verizon) Transmission Services for approval of revisions to its Access Service Tariff No 2. This filing proposes the first step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143.

On June 17, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 2, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On June 29, 2021, Verizon filed its responses to Commission staff's First Data Request. MCImetro Access Transmission Services Corp. dba Verizon Access Transmission Services requests an effective date of July 1, 2021.
