On June 14, 2021, the South Dakota Public Utilities Commission (Commission) received a filing by Peerless Network of South Dakota, LLC (Peerless) for approval of revisions to its Switched Access Services Tariff No. 1. The revisions are being made to address the Federal Communications Commission's rules related to Toll-Free Originating Access Service rates. Peerless requests an effective date of July 1, 2021.

On June 17, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 2, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On July 14, 2021, Peerless responded to Commission staff's data request and filed revised tariff pages.
