

1-5. Explain in detail how Midstate used/plans to use the grant funding it received from the Governor's Office of Economic Development.

RESPONSE 1-5: The Company has used the grant funding received by it from GOED primarily to install fiber optic cable to serve the area in the vicinity of the George Mickelson Shoreline Drive in Oacoma, South Dakota. The George Mickelson Shoreline Drive runs north of Oacoma along the west shoreline of Lake Francis Case. The newly installed fiber serves several new housing developments, campgrounds, and other businesses that have developed in the area. The remainder of the GOED grant funding has been used to provide service to newly constructed homes in the Company's service area.

1-6. Did receiving the state grant for broadband change Midstate's previously submitted plans for capital additions and/or improvements? Are the areas Midstate used/plans to use the grant funding different from the areas Midstate uses the Federal Universal Service support? Explain.

RESPONSE 1-6: Midstate had planned to provide service to these areas prior to receiving the grant funds from GOED. All of the grant funds were used in areas in which the Company requests Federal Universal Service

support. The majority of the GOED grant funds were used in the area in which the Company operates as a CLEC. A far smaller portion of the funds was utilized in the area in which the Company operates as the ILEC.
