**ORDER APPROVING TARIFF
REVISIONS

On June 29, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from Intrado Communications, LLC (Intrado) for approval of revisions to its Switched Access Services Tariff No. 2. The purpose of the filing is to bring certain switched access rates into compliance with the Federal Communications Commission's (FCC) October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143, regarding 8YY access charge reform. In addition to the revision of certain switched access rates, this filing is made to update certain verbiage in the tariff. Intrado requests an effective date of July 1, 2021.

On July 1, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 16, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On July 12, 2021, Intrado filed a letter explaining why it only submitted revisions to the Toll-Free Database Query Charge rate and not other rate changes in this docket.

ORDERED, that the above-referenced revisions to Intrado Communications LLC's Switched Access Service Tariff No. 2 are hereby approved, effective as of July 1, 2021.
