**ORDER APPROVING TARIFF
REVISIONS**

On June 30, 2021, the South Dakota Public Utilities Commission (Commission) received a filing by McLeodUSA Telecommunications Services, LLC (McLeodUSA) for approval of revisions to its Access Services Tariff No. 3. The filing is made to revise certain switched access rates in compliance with the requirements of the Report and Order, FCC 20-143, on 8YY Access Charge Reform issued by the Federal Communications Commission in WC Docket No. 18-156. McLeodUSA requests an effective date of July 1, 2021.

On July 1, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 16, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On July 6, 2021, McLeodUSA filed an amended Third Revised Sheet No. 70 to include some changes that had been inadvertently missed in the original filing.
