On June 30, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from YMax Communications Corp. (YMax) for approval of revisions to its Competitive Access Provider Services Tariff No. 2. The purpose of the filing is to bring certain switched access rates into compliance with the Federal Communications Commission's (FCC) October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143, regarding 8YY access charge reform. YMax requests an effective date of July 1, 2021.

On July 1, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 16, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received.
