On June 30, 2021, the South Dakota Public Utilities Commission (Commission) received a filing by MCImetro Access Transmission Services Corp. dba Verizon Access Transmission Services (Verizon Access) for approval of revisions to its Access Services Tariff No. 2. With this filing, Verizon Access changes its name from MCImetro Access Transmission Services Corp. dba Verizon Access Transmission Services to MCImetro Access Transmission Services LLC dba Verizon Access Transmission Services. Verizon Access states all terms, rates and conditions remain the same. Verizon Access requests an effective date of August 1, 2021.

On July 1, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 16, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received.
